## Governor, Virgin Islands

In January of 2007, Gov. deJongh became the 7<sup>th</sup> elected Governor of U.S. Virgin Islands. Prior to serving as Governor, Gov. de Jongh was the Commissioner of Finance. He was key to successful financial reforming and boosting the economy of the territory in the early 1990s. He also worked as an executive assistant to the governor's office, and he helped to coordinate better interagency cooperation. In 1992, Gov. de Jongh left politics to pursue a successful business career. He worked as a consultant for Public Financial Management and was one of the creators of the oversight committee to help Washington, D.C. become financially sound. Gov. de Jongh has also been an executive at Lockhart and Chilmark Partners, two large Caribbean real estate firms.

# **GREGORY FRANCIS**

## Lieutenant Governor, Virgin Islands

Mr. Francis was inaugurated as the Lt. Governor of the United States Virgin Islands in 2007. Lt. Gov. Francis spent 27 years in the military; he served in Germany, Puerto Rico, and the Virgin Islands. While in the military, he served as a Command Program Support Specialist, Supervisory Military Personal Specialist and Recruiting and Retention Manager. Lt. Gov. Francis served as the Administrator of St. Croix from 2001 to 2006 when he resigned to announce his candidacy for Lieutenant Governor on the ticket with John de Jongh. Lt. Gov. Francis' reputation for community service involvement has spanned several decades.

She also established the "Healthy Families...Healthy Babies Initiative" on the island of St. Thomas through a grant from the U.S. Virgin Islands government, institutionalizing the healthy start model in the Virgin Islands. With two Ford Foundation grants, she established the "Women of Color: Living in the Virgin Islands: Path to Health Justice Initiative" a reproductive and sexual health and rights training initiative using a human rights framework and then the "Community Action Initiative", which ensured broader community involvement in developing realistic and responsive health care policies in the Virgin Islands.
