News Releases

- *August 19- Remarks by Administrator Seema Verma at the SHIEC Annual Conference. "On this day, 55 years ago the satellite Syncom 3 was launched into orbit. This satellite enabled Americans in the United States, for the very first time, to watch the 1964 Summer Olympics in Tokyo in the comfort of their own homes. Since then, information technology has had amazing advancements and we can now send information across the globe in less than a few seconds, except of course if that information is a patient's healthcare record."
- *August 19- CMS Announces Upcoming Enhancement of Overall Hospital Quality Star Ratings. The Centers for Medicare & Medicaid Services (CMS) is announcing plans to update the quality measurement methodology of the Overall Hospital Quality Star Ratings located on CMS' popular *Hospital Compare* website in 2021. In the interim, CMS will next refresh the Star Ratings using the current methodology in early 2020, ensuring patients have timely access to the most up-to-date hospital quality information while a new methodology is being finalized. Today's announcement represents a major step forward in delivering on President Trump's recent Executive Order on Improving Price and Quality Transparency in American Healthcare to Put Patients First, which seeks "to enhance the ability of patients to choose the healthcare that is best for them."
- *August 20- HHS Awards \$107 Million to Support Health Center Quality Improvement. The U.S. Department of Health and Human Services (HHS) announced nearly \$107 million in Quality Improvement Awards to 1,273 health centers across nearly all U.S. states, territories and the District of Columbia. Funded by the Health Resources and Services Administration (HRSA), health centers will use these awards to improve the quality, efficiency, and value of the health care they provide.
- *August 20- <u>SAMHSA's Annual Mental Health, Substance Use Data Provide Roadmap for Future Action.</u> The Substance Abuse and Mental Health Services Administration released the 2018 National Survey on Drug Use and Health (NSDUH). The annual survey is the nation's primary resource for data on mental health and substance use among Americans.

*August 21- HHS Funds an Additional Year of Ebola Vaccine Manufacturing. As part of the international response to the Ebola virus outbreak in the Democratic Republic of the Congo (DRC) and to meet domestic biodefense goals, the U.S. Department of Health and Human Services' Office of the Assistant Secretary for Preparedness and Response (ASPR) will support manufacturing of an investigational Ebola vaccine, V920, from Merck & Co. Inc. of Kenilworth, New Jersey, known outside the U.S. and Canada as MSD.

*August 21- HHS and DHS Announce New Rule to Implement the Flores Settlement Agreement. Secretary of Health and Human Services Alex Azar and Acting Secretary of Homeland Security Kevin K. McAleenan announced a final rule that finalizes regulations implementing the relevant and substantive terms of the *Flores* Settlement Agreement (FSA). Importantly, the rule will allow for termination of the FSA, and allow DHS and HHS to respond to significant statutory and operational changes that have occurred since the FSA has been in place, including dramatic increases in the numbers of unaccompanied children and family units crossing into the United States.
