CMS will supply contractors with the ASP and Not Otherwise Classified (NOC) drug pricing files for Medicare Part B drugs on a quarterly basis. Payment allowance limits under the Outpatient Prospective Payment system (OPPS) are incorporated into the Outpatient Code Editor (OCE) through separate instructions that can be located in chapter 4, section 50 of the Internet Only Manual (IOM).

I. GENERAL INFORMATION

A. Background: The ASP methodology is based on quarterly data submitted to CMS by manufacturers. CMS will supply contractors with the ASP and not otherwise classified (NOC) drug pricing files for Medicare Part B drugs on a quarterly basis. Payment allowance limits under the OPSS are incorporated into the Outpatient Code Editor (OCE) through separate instructions that can be located in chapter 4, section 50 of the IOM.

B. Policy: This recurring update addresses the following pricing files:

File: October 2018 ASP and ASP NOC -- effective dates of service: October 1, 2018, through December 31, 2018

File: July 2018 ASP and ASP NOC -- effective dates of service: July 1, 2018, through September 30, 2018

File: April 2018 ASP and ASP NOC -- effective dates of service: April 1, 2018, through June 30, 2018

File: January 2018 ASP and ASP NOC -- effective dates of service: January 1, 2018, through March 31, 2018

File: October 2017 ASP and ASP NOC -- effective dates of service: October 1, 2017, through December 31, 2017
