On August 15, 2023, the Department of Health and Human Services and the Department of the Treasury approved New Jersey's application for an extension of its State Innovation Waiver under Section 1332 of the Patient Protection and Affordable Care Act (ACA). New Jersey's approved extension application waives the ACA's requirement for the single risk pool to the extent necessary to implement a state reinsurance program called the New Jersey Health Insurance Premium Security Plan for plan years 2024 through 2028.

It is the Department of the Treasury's final administrative determination that New Jersey's pass-through funding amount for calendar year 2024 is \$608,873,232, which must be used for purposes of implementing New Jersey's State Innovation Waiver.
