

# 2024-2025 CMS Navigator Cooperative Agreement Awardees

Since 2013, the Centers for Medicare & Medicaid Services (CMS) has awarded funding to organizations serving as Navigators in states with a Federally-facilitated Marketplace (FFM). Funded organizations operate as Navigators year-round, using funding from CMS to conduct outreach and education in their communities. They raise awareness among uninsured consumers about the coverage options available to them, help consumers find affordable coverage that meets their needs, and assist them beyond the enrollment process. Navigators make sure consumers have the tools and resources they need to use and maintain their health coverage all year, including help with unauthorized enrollment or switching health plans.

Navigators are required to provide targeted assistance to underserved and vulnerable populations. In the 2024 Navigator Notice of Funding Opportunity (NOFO), we referred to these populations as ‘priority populations.’ Priority populations are often affected by social determinants of health (SDOH), such as geographic location, gender, and sexual orientation. They are also frequently impacted by health-related social needs (HRSNs), such as housing instability, housing quality, food insecurity, and lack of employment, personal safety, transportation, and affordable utilities. All of these factors can have a major impact on people’s health, well-being, and quality of life.<sup>1</sup> The targeted assistance provided by Navigators is critical to improving access to health care coverage for communities that have been historically disenfranchised and disproportionately impacted by significant health disparities.<sup>2</sup> Entities and individuals cannot serve as federally certified Navigators without receiving federal cooperative agreement funding from CMS, authorized in the Affordable Care Act, to perform Navigator duties.

The 2024 Navigator cooperative agreement awards were awarded for a five-year period of performance, which runs from August 27, 2024 through August 26, 2029. The cooperative agreement award amounts listed below under each awardee cover the first 12-month budget period (August 27, 2024 to August 26, 2025). Awardees marked with an asterisk (\*) have been funded to work in more than one FFM state and are listed separately under each FFM state they are funded to work in. All 28 states with a FFM for Plan Year (PY) 2025 will have at least one Navigator awardee organization.<sup>3</sup>
