HETS selects the first 10 HCPCS codes submitted in the 270 request. HETS then drops any HCPCS codes from this group if the HCPCS code can already be returned on the HETS 271 response for preventive, PPV, smoking cessation, or any other benefit. If any HCPCS codes remain, the HETS 271 response provides separate 271 2110C EB segments for prior authorization of each remaining HCPCS code from the first 10 submitted.
