### **Background**

CR 13939 is a maintenance update of ICD-10 conversions and other coding updates specific to NCDs. These NCD coding changes are the result of newly available codes, coding revisions to NCDs released separately, or coding feedback received.

Translations from ICD-9 to ICD-10 aren't consistent 1-to-1 matches, nor are all ICD-10 codes appearing in a complete General Equivalence Mappings mapping guide or other mapping guides appropriate when reviewed against individual NCD policies. Also, for policies that allow MAC discretion, NCDs may change based on current review of those NCDs against ICD-10 coding. For those reasons, some ICD-9 codes that were appropriate before ICD-10 implementation are no longer valid.

- NCD 80.3 Photosensitive Drugs

- NCD 100.1 Bariatric Surgery for Treatment of Co-Morbid Conditions Related to Morbid Obesity
- NCD 110.18 Aprepitant for Chemotherapy-Induced Emesis
- NCD 110.23 Stem Cell Transplantation
- NCD 110.24 Chimeric Antigen Receptor (CAR) T-Cell Therapy
- NCD 160.18 Vagus Nerve Stimulation (VNS)
- NCD 210.3 Colorectal Cancer Screening Tests
- NCD 250.3 Intravenous Immune Globulin for the Treatment of Autoimmune Mucocutaneous Blistering Diseases

NCD coding changes are available. We didn't include any policy changes in this ICD-10 quarterly update. We share NCD policy changes using the current, longstanding NCD process.
