Action Needed

Make sure your billing staff knows about:

- Updates to the lists of HCPCS codes that are subject to the consolidated billing (CB) provision of the SNF Prospective Payment System (PPS)
- Additions, deletions, and revisions of certain radiation therapy, ESRD-related service, chemotherapy, blood clotting factor, remote therapeutic monitoring, and colorectal screening codes from the Medicare Part A and Part B SNF files

Background

CMS periodically updates the lists of HCPCS codes excluded from the CB provision of the SNF PPS. We may pay non-SNF providers for services excluded from the SNF PPS and CB for patients, even during a SNF stay. We only pay SNFs for claims submitted to MACs or DME MACs for non-excluded services.

Non-Therapy Services

SNF CB only applies to services provided to SNF residents during covered Medicare Part A stays. However, SNF CB applies to physical and occupational therapies and speech-language pathology services whenever they're provided to a SNF resident, regardless of whether Part A covers the stay. To ensure proper payment, our systems must edit for services both included and excluded from SNF CB when provided to SNF patients in all settings.

We'll identify recent updates based on coding system changes, not due to redefining services subject to SNF CB. We'll note other regulatory changes beyond code list updates when and if they occur.

Note: MACs won't search their files for incorrectly paid claims for HCPCS codes listed in this CR. However, they'll reopen and reprocess claims you bring to their attention.
