## LEGAL PUBLIC NOTICE of MANDATORY TERMINATION FROM MEDICARE/MEDICAID PROGRAM

The Centers for Medicare & Medicaid Services (CMS) is providing notice that on August 17, 2024, Aventura at Terrace View, 108 Terrace Drive, Olyphant, PA, 18447, a skilled nursing facility in the Medicare program, will no longer participate in the Medicare program. The Medicare provider agreement between Aventura at Terrace View and the Secretary of Health and Human Services (HHS) will be terminated on August 17, 2024, due to the facility's failure to meet Medicare's basic health and safety requirements.

In addition, as authorized by the STATE MEDICAID AGENCY, notice is given that the provider's agreement as a nursing facility in the Medicaid program will also be terminated effective August 17, 2024.

The facility has been notified that Medicare will cease to pay for services furnished to Medicare and Medicaid beneficiaries admitted after April 10, 2024, although payment may continue for up to 30 calendar days for patients admitted on or before April 10, 2024. CMS is committed to patient safety and quality of care. We are closely monitoring the relocation of Medicare and Medicaid patients to other facilities.

CMS requires facilities to meet certain health and safety standards to be certified as a Medicare provider. Involuntary termination of a provider agreement is generally a last resort after all other attempts to remedy the deficiencies at a facility have been exhausted. In this instance, CMS has found that Aventura at Terrace View is out of compliance with CMS's health and safety requirements. While we understand that relocation of residents and patients can be challenging for all parties involved, CMS prioritizes patient safety and care quality.
