## CMS Disclaimer-User Agreement Medicare Claims Public Use Files

The Centers for Medicare & Medicaid Services (CMS) is pleased to make Medicare Claims Public Use Files (PUFs) available to the public as free downloads. These PUFs are intended to support studies requiring the use and analysis of Medicare data.

This disclaimer—user agreement details the sources and nature of the data, including potential limitations, and specifies the responsibility of the data user in regard to the processing and understanding of the data files. In addition to this disclaimer—user agreement, users should also read the documentation files for each of the PUFs.

<u>Data accuracy</u>: CMS public data is derived from data that is used by the agency for operational purposes. CMS does not guarantee 100% accuracy of all records and all fields. Some data fields that are not used for agency functions may contain incorrect or incomplete data. CMS publishes data limitations for their statistical data sources on the internet. Users must familiarize themselves with the data limitations documents and accept the quality of the data they receive. For each of the Medicare Claims PUFs please read the General File Documentation, as well as the Data Dictionary and Codebook, before conducting any analyses with the data.

<u>Data integrity</u>: It is the responsibility of each user to identify the information needed to satisfy the user's needs. Any alteration of the original data, including conversion to other media or other data formats, is the responsibility of the user. Data that have been manipulated or reprocessed by the user is the responsibility of the user. The user may not present or otherwise reference data that have been altered in any way as CMS data. CMS has no responsibility for the data after it has been converted, processed or otherwise altered. CMS has no responsibility for assisting users with converting the data to another format. The Medicare Claims PUFs are made available as downloadable CSV files. The supporting files contain specific information concerning file layout, as well as SAS codes for creating a SAS dataset from the CSV files. The Data Dictionary and Codebook files for the PUFs list variables and their definitions, as well as provide frequency distributions.

<u>Privacy protection</u>: CMS is obligated by the federal Privacy Act, 5 U.S.C. Section. 552a and the HIPAA Privacy Rule, 45 C.F.R Parts 160 and 164, to protect the privacy of individual beneficiaries and other persons. All direct identifiers have been removed from these data files; therefore the public data files do not permit direct identification of any individuals. Note that each of the Medicare Claims PUFs are disjoint from each other as well as the existing 5% CMS research sample; there is no overlap of the beneficiaries among the Medicare Claims PUFs and the 5% CMS research sample. The PUFs are designed to prevent identification of individual beneficiaries by record linking to other files released by CMS or other sources. A record for a sampled beneficiary is only included in a PUF if the combination of all analytic variables is shared by at least eleven (11) beneficiaries in the population.

<u>Additional terms and conditions</u>: User acknowledges that CMS reserves the right to amend or modify this disclaimer-user agreement, and that future use of the Medicare PUFs may be subject to revised or additional terms and conditions.
