The MACs have to manually count the OCR claims and adjust the totals on the FISS Workload Reports to populate the CMS MSR. This UCR will correct the FISS Workload Reports to capture the number of 5010 OCR claims received and report it on Page 1, Section D, Line 38.

B. Policy: This is a correction to existing system functionality and has no policy impacts.
