Currently, if a user has update access to the reason code file, it allows the user to update all fields except change of status to deactivate the reason code. This UCR is an enhancement request to create a mechanism to authorize users to update the narrative only portion of the reason code file. This will allow Medicare Administrative Contractors (MACs) to designate users from the impacted departments, such as claims and customer service, to update the internal and external narratives.
