SUMMARY OF CHANGES: The purpose of this Change Request (CR) is to provide a tool for the Medicare Administrative Contractors (MACs) to search the archived claims history for claims that have been deleted from the online system. This tool is necessary for the MACs to implement the appeals process ordered by the Alexander vs. Azar ruling.

II. GENERAL INFORMATION

A. Background: The purpose of this Change Request (CR) is to provide the MACs the ability to identify claims in the archived claims files with minimal information to assist in the research of appeals received in response to the Alexander vs. Azar ruling.

FISS maintains 17 years of claims history. Seven years of claims history is in the offline history file and can be retrieved with an online command. The remaining 10 years are in an archived history file. Archived claims are removed from the FISS online history screens and can only be retrieved if the FISS document control number is known.

This CR will allow the MACs to produce a report of all the claims, for a beneficiary that have from/thru dates within a specific range. The report will provide the details necessary for the MACs to retrieve the full claim using an existing FISS process.
