1. Introduction

The Centers for Medicare & Medicaid Services (CMS) is committed to collecting health care quality data and using it to improve care in the Medicare Advantage (MA) program. Under 1862(e) of the Social Security Act, MA organizations are required to collect, analyze, and report data that permit measurement of health outcomes and other indices of quality. Since 1998, CMS has been requiring health contracts to collect and report quality of care performance measures from Healthcare Effectiveness Data and Information Set (HEDIS^{®1}). HEDIS is a widely used set of quality measures in the managed-care industry, which the National Committee for Quality Assurance (NCQA) developed and continually audits and maintains for providers.

CMS oversees the annual data collection and management of the HEDIS Patient Level Detail (PLD) Data Collection for MA organizations. The HEDIS PLD data are used in the CMS MA Star Ratings and the MA Quality Bonus Payments program. The file specifications are published on CMS's Medicare Advantage/Part D Contract and Enrollment Data page.

1.1 Purpose

The purpose of this document is to illustrate the difference between the HEDIS Measurement Year (MY) 2023 Patient-Level Data File Specifications and the MY 2024 Patient-Level Data File Specifications. It is important to note additions, deletions and modifications between the two years.

2. HEDIS MY 2023 to 2024 Summary of Changes

The HEDIS MY 2024 Patient-Level Data File Specifications, File 1 and File 2 contain updates that are noted in the below sections.

2.1 HEDIS MY 2024 Patient-Level Data File 1

The following measures were deleted from the HEDIS MY 2024 PLD Data File, File 1 of 2:

- Colorectal Cancer Screening (COL)
- Use of Spirometry Testing in the Assessment and Diagnosis of COPD (SPR)

The following measures were revised in the HEDIS MY 2024 PLD Data File, File 1 of 2:

- Updated age band stratification from 65-74 years for Kidney Health Evaluation for Patients with Diabetes (KED) to 65-75 years.
- Updated age band stratification from 75-85 years for Kidney Health Evaluation for Patients with Diabetes (KED) to 76-85 years.
- Updated length from 2 for Pharmacotherapy Management of COPD Exacerbation (PCE) to 3.
- Updated name of the Hemoglobin A1c Control for Patients with Diabetes (HBD) to the Glycemic Status Assessment for Patients With Diabetes (GSD).

The following new measures were added to the HEDIS MY 2024 PLD Data File, File 1 of 2:

- Colorectal Cancer Screening (COL-E)
