Innovation in Behavioral Health (IBH) Model Notice of Funding Opportunity (NOFO) Office Hours September 4, 2024

Isaac Devoid: Good afternoon, everyone, and thanks so much for joining our final office hours session. We really appreciate all the engagement we have gotten throughout these sessions and are really excited to have the opportunity to support you all. As we near the IBH Model Notice of Funding Opportunity or NOFO application due date of September 9th.

As a reminder. My name is Isaac Devoid. I'm a co-model lead for the IBH Model. I'm joined today by Sarah Grantham, the other co-model lead, as well as several members of our model team. I'm also joined today by Jamie Atwood from our Office of Acquisition and Grants Management. Thanks for joining us, Jamie. Before we dig into questions, we wanted to start with some brief housekeeping items.

Sarah Grantham: [For] any folks who've just gotten on the call, we're envisioning this a little bit like college, where, you know, professors [are] kind of just hanging out. Not that we're professors, but just kind of hanging out in their office doing work. And then folks come into the office with questions, we're

happy to answer them. So, we don't have [any] questions and answers sort of prebaked. So, we're just available for you.

Isaac, we did get a question in the Q&A box, "Can primary care providers petition to apply to this program separately from their State Medicaid program participation [or] selection? Or is it exclusively through [the] State Medicaid program?

I'm trying to be honest. I'm trying to understand the question better. Holly, do you want to come off [mute]? She raised her hand. Okay, please jump on.

Holly Hrabik: Hey, yeah, this is Holly. I am from Troop Health in Tampa, Florida. And it says on the website and on the innovation page that state programs will apply for enrollment, and then they will select the participating providers.

Oh, sorry! And I was just wondering if that's exclusively through the state. Like, if the State Medicaid programs, we can petition separately, or is it through the state programs? I don't know. I just saw it on the website that it looked like the state programs had to elect to participate first.

Sarah Grantham: Yeah, that's correct. So, the deadline that we kind of have been focused on is that September 9th deadline, is the deadline to apply through the Notice of Funding Opportunity application, and that is for State Medicaid agencies to apply, and then, after State Medicaid agencies apply, then their awards will be awarded it towards the end of the year, and then after that, the states who are selected will be recruiting practice providers, specialty behavioral health providers, to participate in the model does that answer the question?

Holly Hrabik: Yeah. So, so if, alright. So, if our state's Medicaid agency doesn't get selected or doesn't even apply, then, if we are in that state, then this doesn't apply at all.

Sarah Grantham: That's correct.

Holly Hrabik: Perfect. Thank you so much.

Sarah Grantham: Thanks for the question. We've got another question. When will we know if our State applied? Apologies, you already answered this, and I missed it.

That is a good question. So, as you know, states are required to apply by the 9th of September, and then it's going to take CMS some time to actually review the applications go through the merit review process.

So we won't...you could ask your state if you applied, [and] you could follow up with your State Medicaid Agency. The announcements won't be made until the end of this year [or] early next year. I think it's early next year.

I hope that answers your question.

Isaac Devoid: I saw that we got another question through the Q&A. And the question was, "If we are a state and federal CCBHC, does this our affect our eligibility for this funding?

Can the person who asked this question expand upon that a little bit? I can note that CCBHCs are eligible to participate in the IBH Model, and that you'd first have to be selected by your State Medicaid Agency to participate and receive model funding.

Let me know if that answers your question, or if I can expound on it anymore, or anything along those lines. Awesome, I see that that covers it, so perfect. And please let us know if we can answer any other questions.
