Revised DMEPOS Competitive Bidding Fact Sheet

Program Reminder

On January 1, 2011, the Round 1 Rebid of The DMEPOS Competitive Bidding Program (The Program) was successfully implemented in nine metropolitan statistical areas (MSAs).

On July 1, 2013, Round 2 of The Program is targeted to go into effect in 91 MSAs. In addition, CMS will be implementing a national mail-order program for diabetic testing supplies at the same time as Round 2. The national mail-order program will include all parts of the United States, including the 50 states, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, Guam, and American Samoa.

The DMEPOS Competitive Bidding Program is a change to the Medicare program that is scheduled to go into effect for Medicare beneficiaries with Original Medicare in <u>91 competitive bidding areas</u> (CBAs) across the country starting on July 1, 2013. Under this program, CMS will be awarding contracts to suppliers for certain categories of DMEPOS in the CBAs.

It is important that your staff, such as physicians, social workers, and discharge planners understand this new program so that they can help Medicare patients get covered medical equipment and supplies. Once the program begins, patients with Original Medicare who live in or travel to a competitive bidding area and who need certain medical equipment and supplies will have to get the equipment or supplies from a DMEPOS Medicare contract supplier unless an exception applies. To ensure that Medicare patients' medical equipment and supplies will be covered, partners and providers will have to help beneficiaries find a supplier that is a Medicare contract supplier. Medicare plans to announce the contract suppliers in the spring of 2013.
