# **Technical Expert Panels**

Technical Expert Panels (TEPs) are an effective forum for measure developers to promote transparency, support the inclusion of diverse perspectives, and ensure quality issues critical to patients, caregivers, and other stakeholders are carefully considered in the measure development process.

A TEP is a group of stakeholders and experts who contribute direction and thoughtful input to the measure developer in every phase of the measure development process. During the measure development process, TEP members may

- Review new measure concepts to help determine which should be selected for further development;
- Review the findings from testing for measures under development;
- Advise the measure developer on which measures should be submitted to CMS based on criteria such as whether patients will find the measure(s) meaningful and important; and
- Advise the developer on other quality measurement and measure development topics (e.g., gap

analysis for a program or measure development process improvements).

# Benefits of Technical Expert Panels (TEPs)

TEPs ensure transparency in the measure development process and provide developers with input from multiple stakeholders.

CMS has worked with experienced developers to compile an array of best practices for TEP coordinators to ensure

- A diverse and highly qualified panel is objectively selected
- Patients and caregivers are central to the process
- Members can connect TEP objectives to agency goals
- TEP members are highly engaged in the work

# eCQM Feasibility: How Stakeholders Inform Measure Development

There are several things that CMS looks for when deciding whether a measure might be used in a quality reporting program: measures must be scientifically sound, meaningful to patients, and feasible for healthcare organizations and clinicians to report. Feasibility is an important part of CMS' effort to minimize the cost and resource burden associated with quality measure reporting. CMS requires that all measures undergo feasibility testing before they can be used in one of the quality reporting programs.

For a measure to be considered feasible, it must rely on data that are readily

available and in a format that is usable for performance measurement. For electronic clinical quality measures (eCQMs), this means that data are stored in a format that allows for electronic extraction, and that those data are complete and accurate. To ensure that facilities and clinicians can report on these measures, the data should be coded to widely-recognized terminology standards or have the potential to be mapped consistently to those standards. When testing reveals feasibility concerns, CMS works with developers to weigh the benefits of the

#### Did you Know?

eCQMs rely on <u>nationally-</u> <u>recognized terminology standards</u> for reporting. These standards improve the exchange of health information by creating a common language to define health concepts. measure against the known feasibility challenges to decide whether the measure should be used in a program.
