A New Guide About Technical Expert Panels (TEPs) for Patients and Their Family Members

Technical Expert Panels (TEPs) help measure developers create highvalue guality measures and gather feedback on various quality measure topics. These panels work best when they are made up of a diverse group of people, which includes patients and their family members or caregivers. As TEP members, they can contribute their perspectives to help create measures that are important and meaningful to patients, as well as help to foster a patient-centered measure development process. CMS encourages measure developers to include in their TEPs a minimum of one patient, family member, or caregiver who can share their experience related to the quality measure topic.

To further support patient, family member, and caregiver participation in TEPs, CMS has developed a new resource called, "Becoming a TEP Member: How Patients, Families, and Caregivers Can Make a Difference on Technical Expert Panels (TEPs) to Improve Quality Measures." The quide, an interactive PDF with clickable links, was designed specifically for patients, family members, and caregivers. It introduces them to TEPs, including why and how to get involved. The guide explains:

- Background information on TEPs and quality measures
- How TEPs work
- Ways that patients and family members can contribute to the goals of a TEP
- How to apply for a TEP
- Next steps once selected for a TEP
- Where to find additional resources

This is a resource for you!

How to Find out When a Measure Will Be Implemented Using CMIT

If you need to know when a measure will be implemented to track payment or performance dates, you can find this information online by using <u>The CMS Measures Inventory</u> <u>Tool (CMIT)</u>. Follow these steps to find out when a measure will be implemented:

 Search for the measure topic that you're interested in. Type keywords (e.g., hospital 30-day RSMR), National Quality Forum (NQF) ID, or measure titles in the search bar and click on the yellow button with a magnifying glass icon.

Note: You can also use the filters to the left of the results table to search.

- On the left-hand side of the results table, under "FILTERS," click on "Current status."
- In the pop-up window that appears, select "Finalized." Then close the pop-up window by clicking the "x" in the top right corner.

Note: Measures with a status of "finalized" have been finalized in a Federal Rule for use in a CMS program and will be implemented within a designated timeframe.

- In the results that appear, click on the title of a measure you want to know more about.
- 5. Then, click the "PROGRAMS" tab.
- Click on the program(s) for which the measure is marked as "Finalized" (to the right of the program name).
- 7. Scroll down to "Upcoming Status

Changes." In the row that says "Implemented," the "Effective Date" is the date when the measure status changed from "Finalized" to "Implemented" for that specific program.*

*Note: Many measures with a finalized status have a defined implementation date, but not all measures will have that information in CMIT. If you find a measure that doesn't have an implementation date, please email

CMS Resources for eCQM Development: The Collaborative Measure Development Workspace

The Electronic Clinical Quality Measure (eCQM) Strategy Project is an ongoing effort of the Centers for Medicare & Medicaid Services (CMS) and is part of our ongoing commitment to promote efficiency through health information technology while decreasing burden to providers. CMS has now expanded the Electronic Clinical Quality Improvement (eCQI) Resource Center (RC) to include a <u>Collaborative Measure Development (CMD) Workspace</u>. The CMD Workspace brings together a set of interconnected resources, tools, and processes to promote clarity, transparency, and better interaction across stakeholder communities that develop, implement, and report eCQMs.

The initial release of the CMD Workspace includes a landing page, with information about the five planned modules housed in the Workspace, and the first module to go live, the Data Element Repository (DERep), which contains definitions for standardized eCQM data elements currently used in CMS quality and value-based programs. The DERep clearly presents data element definitions for eCQMs used in CMS' Hospital Quality Reporting Program, Promoting Interoperability Programs, and the Quality Payment Program (QPP). The DERep should provide clarity for clinicians, quality measurement specialists, electronic health record (EHR) vendors, and information technology staff when representing and mapping data required for eCQMs used in these programs. All 16 hospital eCQMs are included in the initial version of the DERep, along with eight QPP eCQMs. The remainder of the QPP eCQMs are planned for publication in the DERep by the end of February 2019.

Look for forthcoming communication on go-live timelines for the other four planned CMD Workspace modules that will include: eCQM Concepts, New eCQM Clinical Workflow, eCQM Test Results, and automated Updates on eCQMs under development.
