Measures Management and You

Quality measures are used to evaluate healthcare quality and to provide a basis for improving healthcare programs across the United States. CMS uses the Measures Management System (MMS) to standardize the business processes and tools for creating, implementing, and maintaining quality measures. CMS also relies on the <u>Blueprint for the CMS Measures Management System</u> ("Blueprint") to document the best practices for developing measures and evaluating quality of care.

For nearly fifteen years, measure developers have followed the Blueprint in the development and implementation of quality measures. The Blueprint is regularly updated and is currently in version 11.2.

CMS also holds events to reach out to the public and elicit feedback on the measure development process and on specific quality measures. Measure developers post requests on CMS' website for public comment on their measures, or solicit public participation in review groups. <u>Technical Expert Panels (TEPs)</u> are a type of review group that reviews quality measures and makes recommendations on their use or improvement. TEPs are comprised of individuals with various areas of expertise and backgrounds.

What's New with the Blueprint?

Here's the latest information on updates to the Blueprint.

The following updates are included in version 11.2, which was released this month:

- More details on the *communication and governance roles* between CMS and measure developers
- An expanded discussion on person and family (caregiver) participation and engagement
- Additional guidance on the development of the *business case* for a measure
- Further discussion of *measure classification* by domain, NQS priority, and setting
- Clarifying language on *different measure types*
- Extensive new detail and template for *environmental scans*
- Standardized semantics for measure titles, descriptions, numerator/ denominator statements, etc.

The next iteration of the Blueprint, version 12.0, is anticipated for release in April 2016.

Measures Management Up Close

Each month, we will bring you an introspective look at a measure management topic.

The History of the Measures Management

System. In October 2003, CMS launched a project to design and implement the MMS. The CMS MMS Blueprint was designed based on the quality measurement work at CMS, augmented by the best practices of other major measure developers. Sound business process management principles such as Lean methodology were also incorporated.

Since its initial release, the Blueprint has been updated regularly to reflect changes in the regulatory environment, such as initiation of the Patient Protection and Affordable Care Act of 2010 and the American Recovery and Reinvestment Act of 2009. Blueprint updates also reflected changes in healthcare quality measurement science, industry trends, National Quality Forum (NQF) policies and processes, and the evolving needs of measure developers. On an ongoing basis, input from stakeholders such as CMS staff and measure developers is collected systematically and considered for incorporation in subsequent versions.
