

Meaningful Measurement in Action: CMS Announces Release of 2018 National Impact Assessment of Quality Measures Report

We are excited to announce the posting of the 2018 National Impact Assessment of the Centers for Medicare & Medicaid Services (CMS) Quality Measures Report at CMS.gov that provides valuable information to guide us in our commitment to put patients first. CMS conducts and publishes an assessment of the quality and efficiency impact of the use of endorsed measures in CMS programs every three years as required by statute. The first report was published March 1, 2012 and the 2018 Impact Assessment Report is the third such report. The data-driven results of this Report support the use of measures implemented in CMS reporting programs to drive improvement in the quality of care provided to patients in facilities and across settings nationwide. This report is used by the measure developer community, patients and families, clinicians, providers, federal partners, and researchers.

The 2018 Impact Assessment Report demonstrates that performance on CMS measures contributed to better care and reduced expenditures, and identified critical areas of improvement across settings with respect to six CMS quality priorities: patient safety, person and family engagement, care coordination, effective treatment, healthy living, and affordable care. As we move ahead, the Report provides insight into how we can achieve our goals to employ highperforming, meaningful measures, reduce reporting burden, and empower patients and providers to make health care decisions while promoting innovative, ongoing quality improvement in health care nationwide. Now Open! JIRA MUC Project 2018

JIRA is now open to collect candidate measures for the CMS 2018 Measures under Consideration (MUC) List. If you are an authorized user of the 2017 or prior years' JIRA web interface for the MUC List, you should have access to the new 2018 MUC Project.

New candidate measures for most CMS programs will be accepted until June 15, 2018. If you have a *quality* measure for Merit-based Incentive Payment System (MIPS), the last day to submit your measure in JIRA is June 1, 2018.

For access to JIRA and the 2018 MUC Project, you must have an ONC JIRA account in place and then be granted permission to the Project. Visit the <u>CMS Pre-Rulemaking website</u> to locate the <u>Measures under Consideration User</u> <u>Guide</u> and <u>Quick Start Guide</u> for more information.

Call for Nominations: Measure Applications Partnership

The National Quality Forum (NQF) is seeking nominations for organizations and individual subject matter experts to serve on the <u>Measure Applications Partnership</u> (MAP). MAP is a public-private partnership convened by NQF to provide input to the Department of Health and Human Services (HHS) on the selection of performance measures for public reporting and performance-based payment programs. This unique collaboration fulfills a statutory requirement to convene multistakeholder groups to:

- Identify the best available performance measures for use in specific applications;
- Provide input to HHS on measures for use in public reporting, performance-based payment, and other programs;
- Encourage alignment of public-and private-sector performance measurement efforts; and
- Address performance measurement gaps.

NQF seeks a range of expertise on MAP to ensure that diverse stakeholder perspectives are represented across settings and populations. Organizations and individuals selected will serve three-year terms and are eligible for reappointment. **Materials to Submit:** Nominations are sought for organizations and individual subject matter experts. Nominations for individual subject matter experts may be self-nominations or may be nominations submitted by a third party. Nominations for organizational members may be submitted by an individual associated with that organization. If selected as an organizational member, the organization's leadership will then designate a person to serve as their representative. Nomination materials should be submitted via the <u>NQF Committee</u> <u>Nominations</u> webpage. **Deadline for Submission**: All nominations MUST be submitted by **Friday, March 30 at 6:00 PM Eastern Time.**
