

## BPCI Advanced Clinical Episodes to Quality Measures Correlation Table – MY6

Last Updated: July 2024

### Overview

Starting in 2021, Model Year 4 (MY4), Participants were required to select Clinical Episode Service Line Groups (CESLGs) instead of Clinical Episode (CE) categories. Also, in MY4 and beyond, Participants will have the flexibility to be assessed on quality by selecting either the Administrative Quality Measures Set or the Alternate Quality Measures Set, for each CE within a CESLG that they have committed to be held accountable. To aid Participants in their selections, this document identifies each CESLG; the aligned Model Year 6 (MY6) CEs with corresponding Medicare Severity–Diagnosis-Related Groups (MS-DRGs), Healthcare Common Procedure Coding System (HCPCS) codes, or International Statistical Classifications of Diseases (ICD) 9<sup>th</sup> or 10<sup>th</sup> revision; the aligned Administrative/Alternate Quality Measures; the National Quality Forum (NQF) or Quality Payment Program (QPP) number, if applicable; and the data source for each quality measure.
