

BPCI Advanced Clinical Episodes to Quality Measures Correlation Table – MY7

Overview

Clinical Episodes (CEs) are structured within Clinical Episode Service Line Groups (CESLGs). Participants are accountable for all CEs within their chosen CESLG(s). Participants have the flexibility to be assessed on quality by selecting either the Administrative Quality Measures Set or the Alternate Quality Measures Set for each CE. Therefore, Participants may select different quality measure sets for CEs within their chosen CESLG(s).

To aid Participants in their selections, this document identifies each CESLG; the aligned Model Year 7 (MY7) CEs with corresponding Medicare Severity-Diagnosis-Related Groups (MS-DRGs), Healthcare Common Procedure Coding System (HCPCS) codes, or International Statistical Classifications of Diseases (ICD) 9th or 10th revision; the aligned Administrative/Alternate Quality Measures; the National Quality Forum (NQF) or Quality Payment Program (QPP) number, and CMS Measure Inventory Tool (CMIT) ID as applicable; and the data source for each quality measure.
