SUBJECT: Notice of CMS Kidney Care First Practices and Kidney Care Entities Participating in Performance Year 2023 of the of the Kidney Care Choices (KCC) Model

The Center for Medicare and Medicaid Innovation (Innovation Center) is excited to announce that 4 CMS Kidney Care First (KCF) Practices and 50 Kidney Contracting Entities (KCEs) are newly participating in Performance Year 2023 (PY2023) of the Kidney Care Choices (KCC) Model, which started January 1, 2023. These KCC entities join 26 KCF Practices and 50 KCEs continuing in the model from PY2022 to PY2023. The KCC entities will serve Medicare fee for service beneficiaries in 47 states as well as in the District of Columbia. Of the PY2023 cohort 27 KCEs have selected the Global Option, 14 have selected the Professional Option, and 9 have selected the Graduated Option (Level 1 or Level 2).
