SUBJECT: Shared System Enhancement 2018: Remove Remaining Obsolete Access Restriction by Granular User Services (ARGUS) Processing

I. SUMMARY OF CHANGES: ARGUS processing was confirmed by the MACs and CMS as being obsolete with the R2018100 release and efforts were taken to remove ARGUS related processing from the MCS. During recent SME research efforts for a release CR, it was discovered that there are still a few ARGUS-related fields referenced within the MCS copybooks and programs that are used in the RU73 job. The remaining fields and program references will be removed from the MCS application with this change request.
