I. GENERAL INFORMATION

A. Background: The purpose of this change request is to notify all interested parties that the Centers for Medicare & Medicaid Services (CMS) needs to assign a new contractor workload number for the Trispan Missouri Part A workload. Trispan currently processes the Missouri, Louisiana and Mississippi Part A workloads in a single CICS region. This workload will be transitioning in the future to two different Medicare Administrative Contractor (MAC) jurisdictions. To facilitate the MAC transition, CMS has decided to split this workload into 2 separate CICS regions at the Enterprise Data Center (EDC) and to assign a separate contractor number to the Trispan Missouri Part A workload.

Currently, all of the Trispan Missouri, Louisiana and Mississippi Part A workload is identified by contractor number **00230**. The Missouri Part A workload shall now be identified separately by contractor number **00242**. The CICS region split is currently scheduled to occur on or after October 1, 2007 simultaneously with the transfer of the workload to the EDS Enterprise Data Center (EDC), at which time live production with the new contractor number will begin. The Medicare contractor will need to begin testing with the new contractor number 6 weeks prior to that date.

The following applications or entities will need to accommodate the new contractor number for both testing and production: BESS, CAFM, CASR, CERT, CMIS, the CMS HDC, COBA, CROWD, CSAMS, CWF, DCS, ECRS, FISS, HCIS, IRIS, MPaRTS, NGD, the NPI crosswalk, OSCAR, PECOS, PIMR, PORS, PS&R, the PSC, PSOR, PULSE, REMAS, REMIS, STAR and SuperOp..

In the event the CICS region split needs to be delayed, the CMS will provide as much notice as possible to the above system owners, but no less than five business days prior to the planned transition date. The above listed systems will need to be able to accommodate such a delay in the start of production.
