**SUBJECT: Change to Previous Transmittal Regarding the Discontinued Use of Revenue Code 0910**

### I. GENERAL INFORMATION

**A. Background:** This one-time-notification contains changes to the business requirements document for CR 3194 – Discontinued Use of Revenue Code 0910. The business requirements document for CR 3194 made a revenue code change effective “for claims submitted” on or after October 1, 2004. This is being changed.

**B. Policy:** The revenue code change in CR 3194 will now be effective for claims with “dates of service” on or after the October 16, 2003.
