As you know, Medicare payment for anesthesia services stands at just \$16.19 per unit. This amount does not cover the cost of providing these services to the medicare patients which often are resource intensive relative to other patient populations.

At Vanderbilt we care for a much larger portion of medicare patients than other institutions in our community. Because of this higher proportion of medicare patients and the fact that they require higher staffing costs because of their medical co-morbidities, we are unable to have adequate financial resources to attract enough staff to open all of our operating rooms.
