Federal law requires school districts to provide medical services, including transportation, so that disabled children may attend school and access their education. Under the proposed rule, we would continue to be required to provide transportation services, but without reimbursement, causing my school district to have to make up the costs in a manner that would impact all children in the district. The narrow view of the proponents of the proposed rule is that disabled ehildren are "transported from home to school primarily to receive an education, not to receive direct medical services". However, for disabled children, medical support services and education are often intertwined.

The administrative activities that are currently reimbursed insure that students from low income families have access to health care services so that they can attend school ready to learn. We have a high proportion of medicaid eligible students in our district that may not receive needed medical care for dental problems, vision problems, asthma (also a high prevalence in our district), and diabetes, for example, due to staff not being funded to make a concerted effort to support parents in obtaining health services. Our district may lose over \$500,000 in funds that can be used to support proper health, mental health, and preventative services for students. Our district staff knows full well the impact poor health has on students, and in many cases, students are not accessing health care, through no fault of their own. Continued reimbursement for medical administrative activities would allow staff in our district to spend the time to inform parents about health insurance, medical providers, and good health care for their children. This has been one of the best programs to get health care for low income students; if not for this, parents often wait until a health problem becomes a medical crisis, then head to their local hospital emergency room, which only drives up the taxpayer costs for everyone.

My school district uses medicaid funds to provide health assistants at every school, CPR and first aid training to staff, health and first aid supplies for schools, health education materials for students and parents, insurance information to families, information about free health care (including medications and eyeglasses) to parents, transportation for wheelchair-bound students to medical therapy, and many other things with direct benefit to students. The funds are not spent frivolously. All this care only allows students to come to school rested, healthy, and ready to learn. Cutting off the funds that allow staff in my school district to monitor the health needs of students will only result in increased student absenteeism due to unmanaged illnesses, as well as poor student academic performance due to lingering unmanaged health concerns.

Please consider the impact this proposed rule will have on the children in our public schools, especially in school districts such as mine, with a high poverty rate and increasing pediatric health problems such as asthma, diabetes, and dental decay. It's not fair to the kids, and it's no way to insure that the education we are attempting to provide them will be of benefit. Sick kids can't learn, period. And until the federal government assigns someone else the responsibility for assisting families in obtaining health care for children, then it will continue to fall on the shoulders of the school communities to make sure it happens. Please don't take chances with our nation's most valuable resource: the children.

# NC CASE Draft Comments on Proposed Rule 2287-P September 21, 2007

The North Carolina chapter of the Council of Administrators of Special Education is absolutely opposed to the proposed cuts in Medicaid reimbursement under Rule 2287-P. Medicaid reimbursement for legitimate and desperately needed school-based services is essential to the provision of services to eligible children with disabilities in North Carolina. Long experience in many communities has shown that schools are the single location where students in need of such services as well their families can be reached most efficiently. Our organization understands that CMS must address inappropriate claiming on the part of some school districts across the country. That is the purpose of the audit process. Instead of eliminating federal financial participation for costs of effective activities that serve Medicaid-eligible students in schools, CMS should develop reasonable guidance and criteria for any limits and may apply to the allowable use of such funds. In fact, we would strongly support the required direction of those funds toward the services that generated such reimbursements and attendant reasonable support costs.

The approach CMS has taken is akin to going after a gnat with a sledgehammer. If concerns or issues have been identified then CMS now has information to establish regulations to ensure proper claiming. This will then better guide schools in identifying eligible children, promoting efficient access to Medicaid services and providing needed care.

Congress and the Federal government have for many years encouraged Medicaid to share in schools' costs for meeting the medical needs of students with disabilities. Bills and amendments before the last and current Congress<sup>1</sup> indicate this support. Given the growing proportion of uninsured children who lack access to basic health care and the impact this has on their ability to learn it is vital that Medicaid share in schools' costs to see that children's essential health needs are met. Dozens of schools and systems in North Carolina are working with Public Health Departments and other health care providers to coordinate school health programs specifically designed to address unmet health needs of school children. It is clear that good health is essential to academic achievement for children.<sup>2</sup> Every school in North Carolina deals with students who come to school each day with untreated medical, dental and mental health conditions. We are facing rapidly rising numbers of school-age children affected by obesity, substance issues, pregnancy and suicide. School systems simply cannot do this alone.

All public agencies that conduct Medicaid outreach through information sharing and care coordination are eligible for Federal financial participation in the costs of such activities. Why eliminate the only entity that touches all children, public schools? There are over

15,000 school systems in this country that educate more than fifty-three million students. <sup>3</sup> There is no other agency that has so much access to touch and address the needs of disadvantaged youth and their families. Eliminating schools from this process will increase the burden on families; exacerbate health issues, and lower educational achievement.

In our view this proposed rule is in conflict with the Medicare Catastrophic Coverage Act of 1988. It specifically allows Medicaid to reimburse school districts for state plan covered services that schools provide pursuant to the IEPs of Medicaid-eligible children. This proposed rule also runs counter to CMS official statements in the 2003 Medicaid School-based Administrative Claiming Guide, "the school setting provides a unique opportunity to enroll... and to assist" Medicaid-eligible children "access the benefits available to them." Likewise in the Introduction to the Guide, CMS acknowledges, "Contemporary schools are engaged in a variety of activities" to carry out their mission to "help ensure that students come to school healthy...ready to learn [and ready to] benefit from instructional services."

Multiple school districts in North Carolina and across the country have taken this to heart and work very hard to assist families to access Medicaid and SCHIP services. We all have more than enough to do but we collectively do this because we know that healthy children learn more easily than children with unmet health needs. We believe that effective interagency efforts are fundamental to coordinating care and early identification of child health needs.

Now is not the time to further limit schools' resources. Without the ability to participate in the Medicaid reimbursement system we will be less able to ensure that all children in North Carolina receive the education they need to become productive citizens. Most if not all North Carolina school districts have conducted school-based administrative claiming appropriately. If there have been errors we are ready and willing to address them. As educators we know that access to health care is fundamental to academic success for students.

Every school district in North Carolina is deeply committed to helping students achieve their potential. We strongly urge CMS to continue school-based Medicaid administrative activities and state plan-covered services as an effective and efficient means of addressing children's health needs and education.
