This file also contains any other plan crosswalk associations approved by CMS.

	HPMS Crosswalk (Definition)	A new plan added to an existing contract for 2020 that is not linked to a 2019 plan.	
	Crosswalk Edits	The new 2020 plan must have a new plan ID number.	
	Example:	CY 2019 No plan	CY 2020 Plan 003 – county/region A

Status: Renewal Plan	Available for:	All Plans	
	HPMS Crosswalk (Definition)	A 2020 plan that links to a 2019 plan and retains all of its plan service area from 2019.	
	Crosswalk Edits	<p>The 2020 plan must retain the same plan ID as the 2019 plan.</p> <p>The 2020 plan must retain the same service area as the 2019 plan.</p>	
	Example:	CY 2019 Plan 001 – counties/regions A and B	CY 2020 Plan 001 – counties/regions A and B

Status: Consolidated Renewal Plan	Available for:	All Plans	
	HPMS Crosswalk (Definition)	Two or more 2019 plans that consolidate into one 2020 plan.	
	Crosswalk Edits	<p>The resultant 2020 plan ID must be the same as one of the consolidating 2019 plan IDs.</p> <p>The service area of the resultant 2020 plan must have at least one county/region from each of the consolidating 2019 plan service areas.</p>	
	Example:	CY 2019 Plan 001 – county/region A <u>and</u> Plan 002 – county/region B	CY 2020 Plan 001 – counties/regions A and B

Status: Renewal Plan with an SAE	Available for:	Local MA, MA-PD Plan, and PDP Sponsor employer-only Renewals	
	HPMS Crosswalk (Definition)	A 2020 plan that links to a 2019 plan and retains all of its plan service area from 2019, but also adds one or more new counties.	
	Crosswalk Edits	<p>The 2020 plan must retain the same plan ID as the 2019 plan.</p> <p>The 2020 plan must contain the same service area as the 2019 plan and have at least one new county.</p>	
	Example:	CY 2019 Plan 001 – counties A and B	CY 2020 Plan 001 – counties A, B, and C

Status: Renewal Plan with a SAR	Available for:	Local MA and MA-PD Plan Renewals	
	HPMS Crosswalk (Definition)	A 2020 plan that links to a 2019 plan and retains only a portion of its plan service area.	
	Crosswalk Edits	<p>The 2020 plan must retain the same plan ID as the 2019 plan.</p> <p>The 2020 plan must contain at least one county from the 2019 plan.</p> <p>The 2020 plan must not contain at least one county from the 2019 plan.</p>	
	Example 1: <i>Where county B is being reduced from the contract service area</i>	CY 2019 Plan 001 – counties A and B	CY 2020 Plan 001 – county A
	Example 2: <i>Where county B is assigned to another plan</i>	CY 2019 Plan 001 – counties A and B	CY 2020 Plan 001 – county A (Plan 002 - county B is given New Plan status)

Status: Initial Contract	Available for:	New contracts in CY2020	
	HPMS Crosswalk (Definition)	A new plan under a new contract.	
	Crosswalk Edits	There is no link to a 2019 plan in the crosswalk. Initial contracts do not complete the plan crosswalk in HPMS.	
	Example:	CY 2019 N/A	CY 2020 New plan

Status: Terminated Plan	Available for:	All Plans	
	HPMS Crosswalk (Definition)	A 2019 plan that is no longer offered in 2020.	
	Crosswalk Edits	There is no link to a 2020 plan in the crosswalk.	
	Example:	CY 2019 Plan 001 – county/region A	CY 2020 No plan

Status: Terminated/ Non-Renewed Contract	Available for:	All Plans	
	HPMS Crosswalk (Definition)	All 2019 plans under a terminated or non-renewed contract are no longer offered in 2020.	
	Crosswalk Edits	Not applicable	
	Example:	CY 2019 Plan 001 – county/region A	CY 2020 No plan
